1. **Call to Order**-The meeting was called to order at 3:32 p.m.
2. **Approval of the Agenda**- 5-0-0
3. **Approval of the Minutes**-minutes of the April 2016 minutes were approved as presented.
4. **Chair's Report**- The chair (Dr. Mann) stressed the General Education Subcommittee's statement and would like to reiterate the following elements in particular to UNCP's goals and values:
 - Transparency
 - Ongoing Dialogue
 - Using general education data to inform research and make meaningful result
 - Respect the rights and diversity of institutions, including encouraging continued autonomy over the setting of SLOs.
5. Elizabeth Normandy shared comments regarding General Assessment that results are not in at this time. What is being measured is critical thinking and writing. General Education Assessment is easier to determine according to SACs. We were out of compliance but we are getting better. We need to determine if objectives are being taught. Standards should be assessed as Home Grown test are easier. It was also stated by Dr. Normandy that 2010 was the last time that we submitted a report to SACs. Dr. Normandy will provide a spread sheet to the General Education Subcommittee. The National Institute of Learning Assessment (NILO) transparency is more detailed and shows a record of information. The college portrait will go away.

 - Statement of support for Report of the UNC General Education Council continues to stress transparency.
