H. **Academic Support Services**: Robert Arndt, Chair Notes from the Academic Support Services Subcommittee Meeting

Enrollment (Academic Support Center and Writing Center)

Hawk Alerts are comparable to last year at this time. The Tutoring Center has 24 tutors but are looking for more. Tutoring has seen 93 students through September 3rd. Emerging Scholars Program, ESP, is Academic Support Center's proactive retention program. It is invitation only and designed to create a meaningful experience centered on the curricular, co-curricular, and extra-curricular components of student life at UNCP. Participants are required to take UNV 1100 (Strategies for Success) introduces students to the Learning to Learn (LTL) curriculum. LTL is a student success/retention intervention with a promising, innovative approach. LTL is an integrated system of unique, research-based, learning strategies that promote students' transition from rote-memory to inquiry-based learning. In the LTL course, students are graded based on the quality and consistency of their applying the new strategies to their academic course work in all their credit courses. There are a total of 127 students who self-selected to participate in ESP for Fall 2015.

Writing Center

Mike Berntsen is the interim director. So far numbers are almost double last year at this time (110 tutorial sessions versus 46). Part of this is attributed to spreading the word about the services during orientations.

Native American-serving Nontribal Institutions (NASNTI) grant was lost due to password issue. The loss effects the Transfer Transition Programs, and certain tutoring programs (Praxis, NCLEX, MCAT). The project director has applied for a no cost extension, which would allow unexpended funding to be used to continue some grant activities through January or February if it is approved.

Library

The Library offered extended hours during Spring Exams. The Library over the summer provided programs for BAR students and JR Braves. The Library is hoping to be able to advertise for several librarian positions, as well as being a Dean search as Susan Whitt retiring in June 2016.

DoIT

Phase I of the Academic Computing Initiative is completed. Current projects include Viewfinity which allow users to update a some programs without having administrative rights to the computer. Also look at the implementation of Webex which will allow video conferencing. DoIT is also looking at the Respondus LockDown browser (if funding can be identified). If you have any telephone issues (static, dropped calls), please let the Help Desk know.

Accessibility Resource Center

The office has begun the process for 98 new intakes. If anyone has an student accommodation questions, Nicolette asks that they contact her office.
