## **Meeting of the Academic Affairs Committee**

Wednesday, September 17, 2017 University Center, Room 233

I. Call to Order

Richard Vela (Chair) called the meeting to order at 3:30 PM.

- II. Approval of Minutes from April 19, 2017The minutes were approved without amendments.

  Chair Vela asked for a volunteer to serve as secretary. Mitu Ashraf volunteered.
- V. Report from Chair No report.
- VI. Reports from Administrators

David Ward (Provost and Vice Chancellor for Academic Affairs) provided updates on issues related to NC Promise. Student enrolment is expected to increase due to NC Promise. Some of the issues expected to arise include parking, student quality, and course offerings.

With regard to course offerings Provost Ward mentioned that if some of the incoming students under NC Promise were not prepared to take college-level courses, the University might offer remedial courses and might enter into partnerships with the area community colleges where such students would get remedial courses. He mentioned that the administration did not expect any significant changes in the distribution of the student body due to the influx of students entering UNCP under NC Promise.

### VII. Reports from Subcommittees

A. Curriculum Subcommittee: Jaime Martinez
Curriculum Subcommittee Chair did not have any items that required approval from
the Academic Affairs Committee.

# B. Enrollment Management Subcommittee: Melissa Schaub

- a. Associate Vice Chancellor for Enrollment, Ms. Louis Williams, reported that the total was 6252 students, with 1033 new freshmen students, 538 transfer students, and 286 new graduate students. The official retention rate is 68.7 percent.
- b. Mr. Derek Oxendine, Director of the Center for Student Success, reported that
  - i. during summer, New Student Orientation served 1102 freshmen and 565 transfer students
  - ii. the advising model at UNCP would change between now and 2018. New students will be brought in as the advisees of the Center for Student Success rather than the advisees of academic departments. Furthermore, not all faculty members would be expected to serve as advisors. Faculty members who would serve as advisors would use the "EAB Student Success Campus platform." The platform was gradually rolled out. A committee had been formed to look at the possibility of a "university college" model.
- c. Ms. Williams and Mr. Oxendine are on the NC Promise Committee. They will keep the Enrollment Management Subcommittee informed and communicate any issues that various stakeholders may have.
- d. Mr. Oxendine suggested that the University might want to reconsider its practice of admitting transfer students for summer sessions. He mentioned that it was often difficult to enroll transfer students in the needed classes. The Subcommittee asked Ms. Williams to provide data to the Subcommittee before addressing the issue.
- e. The Enrollment Management Subcommittee discussed issues related to online courses and the student retention rate. The Subcommittee also expressed concern of having a "related attendance policy" during weather-related emergency situation.
- C. General Education Subcommittee: Nathan Thomas

The General Education Subcommittee discussed the possible impact of NC Promise on general education. No resolutions were passed. The Subcommittee members were of the opinion that individual academic departments were better suited to plan for the possible impact of NC Promise.
