SWK: updating Advanced Standing summer bridge courses to better align the content with needs of beginning students in the program. Adding two courses (SWK 5330 and SWK 5340—four hours each) and eliminating four courses (SWK 5110; SWK 5120; SWK 5130; SWK 5140 --two hours each—eight hours total. Add new course to electives: SWK 6600.

SWK 5330: Advanced Standing Bridge Course I—4 hr

The SWK 5330 course is a five (5) week bridge course that is fast-paced and requires the student attentiveness to detail. This course is for advanced standing students in the Department of Social Work who have completed the Bachelor of Social Work degree ...

SWK 5340: Advanced Standing Bridge Course II—4 hr-- This course is for advanced standing students in the Department of Social Work who have completed the Bachelor of Social Work degree from an accredited social work program, and have been admitted into the Advanced Standing program. This course is a continuation of SWK 5330. This course will address scholar skills that are necessary to successfully complete the MSW program, specifically in the area of writing and research. Credit: 4 semester hours. PREREQ: Acceptance into the Advanced Standing Program and SWK 5330 completed with a "B" or better.

SWK 6600: Advanced Social Work Practice in Integrated Healthcare—3 hr--The course will introduce students to the essential practice skills needed to effectively address the challenges of integrating services, care, and support for persons with health, mental health, and substance use problems. Students will become fluent in the language and culture of health and will develop a working knowledge of a wide variety of chronic health conditions. Students will examine the challenges of multidisciplinary team practice and current best practices for effective interventions.
