 - d) Tutor.com is an allotted \$25,000 with only 343 unique users (Less than 5% of the student population). 64 students are identified as power users. 1 student used 8057 minutes; we (UNCP Faculty) kept approving this student. 9 students used 375 hours which represents a significant overuse. Math is the primary subject; and the Math instructor is aware of this usage. Shared oversight UNCP and Tutor.com. The University is looking at guidelines and parameters for example 5 hours per student per semester. Tutor.com costs \$28.00 per hour; and is an asynchronous model. After midterms, an additional hour could be added; and prior to midterms an additional 2 hours could be added. Eliminate the Writing/Essay Drop-off, but would still have access to the live writing center on Tutor.com. Face-to-Face tutoring costs about \$10.00 per hour and much more interactive.

Academic Engagement Program Updates

Probation

- Academic Success Contract for the spring 2020 has been updated. All returning probation students will be grandfathered under the old provisions of their contracts.
- Online only students will be required to complete online workshops and the online module will be created. Exploring Web Ex as the primary functionally of executing this process.
- Probation students will begin meeting bi weekly with their advisors to address any immediate academic concerns. Advisors will run campaigns on their students to ensure outreach of them being aware of the meetings.
- Exploring online ASC contracts for online only students.

UNV 1100: Strategies for Success

- Being disruptive

As a result of this, the study hall staff received their first visit from three football coaches, to include observing their students' actions first hand. Potentially more site visits from the coaches will be performed in the near future.

Library Overview:

The library has been making great progress on several fronts. The special collections have been gone through and weeded (many things were being kept that were no germane to our collection needs or were items that are officially retained elsewhere, e.g. Board of Governor minutes). Thousands of old faculty committee meeting minutes were digitized and the paper discarded. The *Pine Needle* from 1948 forward is now digitized and available online as are a series of audio recordings from Adolph Dial. We are continuing this process.

The implementation of the new Integrated Library System (ILS) is progressing with the last piece of the three (the *Ex Libris System* has three components: *Alma*, the main part of the system;

Primo, the integrated single search system; and Leganto, the integration of the library into Canvas the classroom system. Leganto is being tested for the remainder of this semester and will be available campus-wide in Spring. We are also adjusting the operational hours of the library. To meet student requests and needs the library will be open Sunday to Thursday from 8am to 2am. We were able to hire two new circulation workers by collapsing a library position. It must be noted that while this gives us short-term relief, the library is still woefully understaffed. Overall, we have the lowest number of library staff of any of the UNC system schools. We currently have .85 librarians per thousand students. The national and system average are about 3.2. Our overall staffing is now lower than five years ago, even though we have roughly 2,000 more students.

September 2019: Dr. Swanson was a panelist on a Library Journal national podcast on the "Future of Academic Libraries in America."

November 2019: Dr. Swanson presented the results of the "State of the Academic Library: Results from the 2019 Academic Libraries Survey," at the Charleston Library Conference.

Roger Cross published several reviews in *Against the Grain*, a professional academic library journal.
