- I. The meeting was called to order at 3:30pm.
- II. The minutes were approved after making one minor change.

- V. Review of items from the last meeting.
 - Use of the words "policy" and "regulation."
 - O The word "policy" can only be used to refer to "any standard, statement or procedure of general applicability adopted by the Board of Trustees..." so committee members will look for uses of "policy" in Section I of the Handbook which are not consistent with this usage and propose changes at the next meeting. The committee will replace the term as needed on a case by case basis with an appropriate synonym such as practice or procedure or coin a new term such as: politik (from German) or consilium (from Latin).
 - The committee reviewed the expiration of terms for members.
 - At the November meeting, the meaning of "Academic Rank" as used in the Faculty Handbook (e.g. pg. 14) is never defined and should be clarified. After consultation with Faculty Senate Chair, this issue will be referred to the subcommittee on Faculty Development and Welfare.
 - Another question which arose at the previous meaning was concerning whether the
 phrase "in writing" could be interpreted to include email communication. The Faculty
 Senate Chair proposed that it should be made clear that documents in any form which is
 distributable to Senate or its committees should be allowable. The COFH Chair will ask
 the Senate to take up this change.
