Probation

Off to a good start this spring semester. The library was repainted on the first floor and some carpet is being replace throughout the building. The café has adjusted their hours and limited their menu as this is run by Sodexho.

Hours of the library are updated on the website but continue to be the same as past semesters during the governor's executive order with the curfew. We are closing at 9pm to provide travel time for our employees to make it home in time.

A faculty newsletter is coming out this week as the library is striving to improve our campus communication to promote library services outside the building.

The library is a member of ULAC (University Library Advisory Council) and they are encouraging the library to promote the OER Open Education Resources.
