

Existing Site Conditions

Health Sciences Center at UNC Pembroke is located in the northern half of campus, south of the stadium, northwest of Pembroke. The address is 1 University Drive, Pembroke, NC 28372, in Robeson County.

The existing apartments will be demolished, as well as some parking along Prospect Road and to the south side of the property. Pedestrian circulation borders the site. Views from the public face are open and there is little tree cover other than the stand of pines and mixed hardwoods in the southwest portion of the site
