DF Lowry HVAC Project

Our DF Lowry facility recently experienced an HVAC outage impacting the entire facility and its occupants. Facilities discovered the issue Monday morning. Dean Jacobs immediately brought in a service provider to troubleshoot the issue. He already had a service provider scheduled to be on campus for another project and could call them immediately. This minimized travel time and costs. Once a determination was made of what the issue was, Dean put an action plan in place.

Dean and his team immediately provided mobile spot coolers for critical office spaces within the facility.

Dean had our service provider gather information for a repair proposal ASAP.

Dean began obtaining materials and equipment to connect our temporary chiller to the facility.

Finally, a call was made to the manufacturer to see if there was an opportunity to receive assistance from them. This appears to be premature equipment failure.

By Thursday, July 13th, the temporary chiller was operational, and the entire facility was cooled.

focused Dean remained and dedicated to the task. and coordinated all aspects both of temporary and permanent solutions simultaneously. All the while, a new student orientation was scheduled for Friday and Saturday this week. With well over a hundred new students along with parents participating in programs on campus, and particular, the DF Lowery facility being the main hub, the timing was critical, to say the least.

Dean is currently coordinating the permanent repairs with the aggressive goal of having them completed over the weekend.

Dean and team, thank you for your dedication, ability to remain focused under pressure, and innovative efforts to address this need in record time, at an opportune time when UNCP needs to shine brightly.

Equal Employment Opportunity & Diversity Fundamentals (EEODF)

In accordance with the North Carolina general statute 126.16.1, all managers and supervisors are mandated to attend EEODF training coordinated through The North Carolina Office of State Human Resources (NC OSHR) within one year of their appointment. This training addresses EEO law compliance and issues of workplace diversity in state government and focuses on developing awareness and building skills to be used on the job to assist managers and supervisors in understanding important employment discrimination laws that impact day-to-day managerial decisions. Case studies and other activities are used to learn how to apply the laws' principles to create fair, equitable, and inclusive work environments. The skills taught in EEODF enable university managers and supervisors to address complex diversity issues in a legally compliant manner.

Attendees must complete a series of online modules prior to attending the training session. It is important to ensure you have at least two (2) weeks to complete the modules, prior to enrolling in the class. Modules cannot be completed the day before the training. You may access NC OSHR's online learning management center via https://ncgov.csod.com/client/ncgov/default.aspx. NOTE: All online modules and the assessment must be completed before you have the option to register for an available

classroom session. You will not be admitted to a classroom location without completing all learning objects.

UNCP's Office of Human Resources will provide multiple opportunities to participate and register in a one-day EEODF training session from 8:30 a.m.

-4:30 p.m. offered on the following dates:

- Tuesday, October 24, 2023
- Tuesday, December 12, 2023

Remember to File Your Wellness Benefits

Starting January 1, 2023, participants of the NCFlex **Accident** and **Critical Illness** Plans (administered by Voya) became eligible for a wellness benefit. This benefit is payable once per year, per covered person for completing an eligible health screening test. The deadline to file a wellness claim through Voya is six months after the screening or at the end of the plan year, whichever is later.

If you participate in both plans, you can receive a wellness benefit from each for the same screening! <u>Learn more about eligible</u> <u>screenings and how to file a claim here.</u>

The NCFlex **Cancer** Plan (administered by Allstate) also has a wellness benefit, payable once per year, per covered person. Allstate's **wellness benefit** does not have a filing deadline. Non-University employees can access their Allstate account under "Quick Links" in the **eBenefits platform**. Anyone can access their account by visiting **www.allstatebenefits.com/mybenefits.**

Some screenings may overlap all three plans (Critical Illness, Accident and Cancer), meaning you could potentially have a wellness benefit from all three plans if enrolled.
