Call for Abstract/Proposal for the 6th Annual Southeastern Social Work Conference

2025 ANNUAL CONFERENCE at THE UNIVERSITY OF NORTH CAROLINA AT PEMBROKE

THEME: Social Work Practice as a Tool for Empowering Underserved Communities

The Planning Committee invites proposals for the 6th Annual Southeastern Social Work Conference in Pembroke, NC, March 6-7, 2025. This year's conference focuses on a continuum of social work practice interventions that makes Underserved communities stronger and confident in controlling their own lives. Abstracts may be submitted for presentation within the following content areas:

Navigating Social Worker Roles in Racial and Ethnic Minority Communities:

Presenters may share experiences and outcomes of how social workers are working with ethnic and racial minority (e.g., Indigenous people, African Americans, and Latinx) families and communities to take control of their own narratives and further their personal and societal goals that align with their culture.

Ethnic Cultural Practices and Belief Systems as a Foundation of Social Work Practice:

Abstract may focus on how ethnic beliefs and customary practices (e.g., customs, spirituality, ancestral wisdom, storytelling, crafts, and folklores) can be used as social practice frameworks or integrated into social work interventions.

Adoption and Outcomes of Telehealth and Digital Health:

Presentations may highlight usage, adoption and outcomes of social service delivery technologies in Underserved communities.

Recruitment and Work Environment of Social Workers:

Abstracts may cover experiences and outcomes of strategies designed to recruit social workers and create supportive work environment and responsive social work practice in rural communities. Topics may include burnout mitigation strategies, mentoring opportunities, mental health support and coping strategies, etc.

Ethical Values, Human Rights, and Legislative and Policy Actions:

Abstracts may focus on ethical issues, human rights, advocacy, legislative initiative, and community development efforts aimed at illuminating the challenges face by Underserved communities and elevating the voices of community members.

Maternal and Child Health in Underserved Communities:

Presentations may cover the roles social workers play in protecting the health and wellbeing of mothers and children in Underserved communities. Topics may include breastfeeding, nutrition, mental health, mortality and morbidity, Neonatal Abstinence Syndrome (NAS), childhood obesity, contraception and family planning, healthcare access, and ethnic cultural practices and belief systems that impact maternal and child health and wellness.

Underserved defined: An Underserved community refers to a group of people or geographic area that faces barriers accessing basic needs (e.g., good and affordable housing, food, education, healthcare, clean water, internet access, job opportunities, electricity, employment and employability skills, etc.). Underserved communities or groups may include ethnic and racial minorities, rural communities, children, women, people impacted by substance use, seniors, individuals with disabilities, immigrants, people impacted by persistent poverty, people who are vulnerable to discrimination, etc. (Glossary Section: NFIP - National Flood Insurance Program, n.d.).

Proposal Submission Guidelines and Timelines

Abstract

Requirements

Review the submission requirements below prior to developing and submitting your abstract.

Learning Outcomes: State two observable and

measurable learning outcomes for conference attendees who attend your session.

Abstract Narrative: The abstract should offer a

fairly detailed sense of the paper without exceeding 500 words. Abstract should include the background and purpose for the paper, research methodology, summary of results, conclusion and implication for social practice and policy in Underserved communities.

References: Provide a minimum of three appropriate references (APA style).

Abstract Selection

Criteria

Relevance: The abstract addresses social work practice empowerment issues important to Underserved communities and shows how the intervention empowers them.

Evidence and Practice Application: The abstract

includes relevant evidence that support initiating similar practice interventions in similar communities and provides information to support how the intervention could be adopted.

Originality: The abstract offers innovative ideas and practices that stimulates thoughtful reflection on social practice interventions in Underserved communities.

Coherence: The abstract is focused and easy to follow.

Presentation

Format

Oral Paper Presentation: Abstracts may be

submitted for a 30 minute oral presentation. Presentation may be grouped together based on a single theme and similar content within a 60-90-minute concurrent session. If presentations are grouped, a moderator will facilitate an extended period of open discussion following the presentations. During the

abstract submission process, authors should indicate their willingness to present an individual poster, if submission cannot be scheduled as an individual paper due meeting time and space limitations.

Poster Presentation: Poster allow presenters to discuss their work with conference attendees for 60-90 minute block of time. Posters are designed by the presenters and will be displayed during their designated block time for interaction with conference attendees.

Workshop: Workshops have specific learning objectives and are intended to offer training opportunities for conference attendees with hands-on instructions. Presenters are encouraged to submit workshop proposals on any topic, as long as the workshop's objectives will enable conference attendees to gain practice knowledge and skills that are important to social work practice in Underserved communities.
